

Brantling Bluegrass Festival

Vendor/Exhibitor Information

The 9th Annual Brantling Bluegrass Festival will be July 27 – 30, 2017 at the Brantling Ski Slopes, 4015 Fish Farm Road, Sodus, NY 14551.

Campers will begin arriving on Wednesday, July 26. There will be music workshops offered during the afternoon of July 27 and the stage performances will run from 5 PM until 10 PM. On July 28 & 29, there will be morning workshops starting around 9 or 10 and stage performances will be from 11 AM until 10 PM. The Sunday morning program is only one hour and many of the campers will be leaving, so it's probably not prime time for vendors.

The Vendor fees are as follows:

Weekend (may set up on 7/26)	\$50
Friday or Saturday only	\$40
Electricity for weekend	\$30
Electricity for one day set up	\$20
Vendor Camping for up to 2 people	\$10/day

Other information:

There are only two workers allowed for each vendor space at no additional charge. Workers may alternate, but no more than two at a time. Additional workers will be charged \$20 per day or \$50 for the weekend. All vendors and workers are expected to check in at the gate.

Vendors will not be able to camp with their exhibit and there is no electricity or water available for campers.

Vendor spaces are typically 12' x 12' and vendor will supply their own shelter, tables, and chairs. Exceptions possible on case by case need and may incur additional charges.

Vehicles will need to be moved out the vendor area during peak times (to be announced).

Vendors are to keep their spaces neat and clean and are responsible for clean up of their assigned area following the event. Small amounts of trash may be put in dumpsters provided.

Vendors are required to comply with all NYS and local ordinances and regulations regarding business transactions including not limited to collecting appropriate sales tax.

Booth structure and contents, including merchandise and personal property, are the responsibility of the Vendor/Exhibitor at all times during the festival including set up and tear down. Brantling Ski Slopes/Brantling Bluegrass Festival does not assume responsibility for injury to persons or loss or damage to any of the property of the Vendor/Exhibitor, including theft, accident, or acts of God. Vendors/Exhibitors indemnify and agree to hold Brantling Ski Slopes/Brantling Bluegrass Festival harmless from any and all claims, liabilities, demands, lawsuits, costs, penalties, expenses (including attorney fees), and judgments due to breach of this agreement by Vendor/Exhibitor or their personnel.
